

ROAD HAZARD WARRANTY

TO QUALIFY FOR THIS WARRANTY:

1. You must be the original purchaser of the tire(s).
2. You must have purchased the tire(s) from Shores Car Care.
3. You must present the original purchase receipt and tire(s) to Shores Car Care.

CONDITIONS OF THIS WARRANTY:

1. The purchaser must rotate and balance their tires as outlined by the vehicle manufacturer.
2. The purchaser must operate their tires at inflation pressures outlined by the vehicle manufacturer.
3. The purchaser must keep all mechanical parts that affects tires in proper working condition.

WHAT IS COVERED:

1. "Road Hazard Failure" is defined as a tire that becomes unserviceable due to cuts, non-repairable punctures or impact damage. Shores Car Care will repair tires with tread-face injuries in accordance with established RMS (Rubber Manufacturers Association) standards.
2. This warranty covers road hazard failures in passenger, and light truck tires purchased from Shores Car Care.
3. This warranty is valid for thirty six (36) months from date of purchase or when the tire reaches 1.6mm (2/32 of an inch) or less in remaining treads depth. When a tire has 1.6mm (2/32 of an inch) or less in tread depth it is considered worn out.
4. This warranty provides free tire replacement due to road hazard.
5. This warranty is a promise under certain conditions to give free tire replacement of the effected tire. This warranty does not imply that tires sold by Shores Car Care meet certain specifications or cannot fail. This warranty does not replace or modify any original tire manufacturers warranty on material and workmanship.

WHAT IS NOT COVERED

1. A tire that is damaged / failed due to vandalism.
2. A tire that is damaged / failed due to an accident.
3. A tire that is damaged / failed due to commercial use.
4. A tire that is damaged / failed due to racing.
5. A tire that is damaged / failed due to off – road use.

6. A tire that is damaged / failed due to snow chains or studs.
7. A tire that is damaged / failed due to irregular wear.
8. A tire that is damaged / failed due to wear from worn mechanical components on the vehicle.
9. Tires transferred from the vehicle on which they were originally installed.
10. Loss of time, inconvenience, loss of use of vehicle or consequential damages, so the above limitations or exclusions may not apply.

MISCELLANEOUS:

A comparable tire may be the same brand and type or in the event the tire is no longer available at Shores Car Care, a tire of the same basic construction will be substituted. A Road Hazard Policy may be purchased for the replacement tire at the cost of the applicable Road Hazard Policy.

This policy gives you specific legal rights, and you may also have other rights which vary from state to state. Some states do not allow limitation on how long an implied warranty lasts, or the exclusions of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

TIRE CARE RECOMMENDATIONS:

1. Have the air pressure in your tires checked by a tire professional at least once a month. Serious injury may result from tire failure due to under inflation.
2. Always request that the air pressure in your tires be set to the tire or vehicle manufacturers' specifications.
3. Do not overload your vehicle. Serious injury may result from overloading your vehicle.
4. Read and follow all tire maintenance requirements outlined in the Tire Manufacturers' Warranty booklet provided at the time of purchase.
5. Fix-a-flat products should be avoided if possible. These products can make a tire non-repairable and does void this road hazard warranty.
6. If you are purchasing less than four tires, mount the new tires on the rear of the vehicle.
7. Request that your tire and rim assemblies are hand torqued with a calibrated torque wrench to the vehicle manufacturers' specifications.
